1. About CHILDLINE 1098

<u>CHILDLINE</u> is a national, 24-hour, free emergency phone outreach service for children in need of care and protection linking them to long term rehabilitation. CHILDLINE service reaches out to children who fall prey to the gaps in the protection mechanisms in the society.

<u>CHILDLINE India Foundation (CIF)</u> is the nodal agency of the Union Ministry of Women and Child Development. CIF is the sole agency/body responsible for establishing the CHILDLINE service in the cities/districts of the country, monitoring of service delivery and finance, training, research and documentation, creating awareness, advocacy as well as resource generation for the service.

Major components of CHILDLINE service

- Intervention and call response.
- District level advocacy with the allied systems and stakeholders for child protection.
- Training for various departments on child protection and legal aspects.
- Sensitization programs for public.
- Encouraging child participation in policy / decision making process.
- Generate case studies, analysis and reports on various child protection issues and preventive strategies

2. CHILDLINE Thiruvananthapuram

CHILDINE Thiruvananthapuram is the first CHILDLINE started in Kerala in the year 2000. Loyola Extension Services (LES) Trivandrum functions as the Nodal Organization of CHILDLINE. LES along with the Collaborative agency, Don Bosco Veedu Society and Support Agency, Trivandrum Social Service Society (TSSS) has done many activities in the city for children. Providing services to the children in need of care and protection, coordinating with Government Departments, networking with the members of the allied system, organizing various programs, etc were done to prorogate the activities of CHILDLINE. CHILDLINE India Foundation provides the necessary support for the smooth functioning of the various activities. In the year 2015-16 CHILDLINE has intervened in 1251 cases in Thiruvananthapuram district of which 370 cases were protection from abuse. Number of physical abuses cases reported in the year 2015-16 was 115.

Protection from Abuse cases in Thiruvananthapuram

In the year 2015-16 there were 370 cases intervened by CHILDLINE Thiruvananthapuram. Here we can see that the Physical abuse cases are high among the intervened cases. Children were even effected burns by the relatives in these cases. The second high category is sexual abuse cases. 22 child marriage cases and 12 child beggary were also reported during the year. 35 child labour cases and 22 corporal punishment cases were also reported.

Over the years there is an increase in the reporting of child sexual abuse cases through CHILDLINE Thiruvananthapuram. In the year 2012-13, 16 CSA cases were reported, during 2013-14 it rose up to 68 cases and in 2014-15 it is103 cases. During the year 2015-16 a small decreasing in the number of CSA cases can be seen.



The data of child Sexual abuse cases intervened by CHILDLINE Thiruvananthapuram shows that both boys and girls are prone to abuse. The data also shows that boys and girls among the age group of 11 -15 years of age are more vulnerable than any other age group. 8 male and 62 female children were abused sexually. It is to be noticed that 5 children below the age 6 were also abused.

Abuser relationship with child

Upon analysing the data it was found that in most cases the abuser is known to the child or has some sort of relationshipwith him or her. Only 9 children were abused by others. 20 children were abused by the near relatives. It is to be noted that the children who are abused are not in a position to respond or complain since the abuser is a relative.

Analyzing the category of abuses faced by the children shows that more than 70% of children face high forms of sexual abuse like sexual assault or penetrative sexual assault, The rise in number of aggravated assaults shows that the children are abused by those who were supposed to give care and protection .

The data analysis shows that the child prefers to reside in their house even though the abuser is a relative or is staying nearby. It shows that the children need care and protection of their parents, but it also has an implication of the vulnerability.

CHILDLINE services in Thiruvananthapuram have a remarkable role in helping the children in need of care and protection which is evident from the data. In 99 % of the cases follow-ups and parent sensitization were done. Follow up counseling provided to children. Children were helped in giving shelter. CHILDLINE team members accompanied children to record the statement. It shows the trust of child to CHILDLINE. **Information**

Continuous awareness and training programs are conducted by CHILDLINE team members for different stakeholders to equip them to report cases. Analyzing the data of person who informed the cases to CHILDLINE shows that 22 parents and 16 teachers were there. It shows that the parent sensitization and teachers awareness programs were effective. ICDS staff, doctors, police etc., also inform the cases to CHILDLINE.

Kerala is witnessing an inflow of migrants. Many come to Trivandrum to find a job. Some of the families beg with their children to earn a living, which is very difficult to stop. CHILDLINE with the support of police department is rescuing the child and providing shelter and restoration for the family. In most of the case of child beggary the children are found with the mother.

Major findings of Analysis of Protection from Abuse cases

- It is found that the children between the age of 11to 15 are more vulnerable when the abuse cases are analyzed.
- We can mark relationship between the family background of the child and the chance of getting abused, poor orphaned, discriminated children, Children who are victims of alcoholic parents, Child whose parents are separated or divorced are more vulnerable
- In almost all the cases parents know the abuser and has relationship which gives space for the abuser to abuse the child.
- The decreasing number of sexual abuse cases against children in Trivandrum district shows the awareness that is created by CHILLDLINE and Government are reaching the public.
- Child Labour and Child Beggary cases are also decreasing in the district of Trivandrum.
- Though the abuser is either the neighbor or relatives or the children are abused in the house, children like to stay with their parents in their own home.
- More than 90% of cases the abuser is known to the Child .

<u>3. ADVOCACY EFFORTS</u>

Team & Coordinators

12 coordinators & 12 team meetings were held during the reporting period. In addition to it a special meeting was conducted in connection with meeting with DCPU. Forty one meetings were conducted in the collaborative agency. The support team conducted forty meetings. The city coordinator visits both collab and support frequently to assess the work and to give proper guidance as and when needed. Various activities and strategies were planned during the meetings to implement the activities effectively. Staff development programs were also initiated during the period.

Directors' Meeting

Two Directors meeting were held during the reporting period. And in the meeting major decisions on awareness creation, CAB meeting, RO meeting Etc, were planned

CAB Meeting and DCPC Meeting

CHILDLINE Trivandrum has the honour of having the Additional Chief secretary as the chairman of the CAB. This year the CHILDLINE Advisory meeting held on 19/09/2015 at Govt Secratariate Trivandrum. CHILDLINE District Coordinator, Mr. JOBI gave report of the activities and the details of case followed up during the previous months. Major decisions like Interface with DCPU, CWC and CHILDLINE has come in to effect

during the financial year. One District Level CWC. **CHILDLINE** and DCPU meeting was conducted to increase the linkage and decided to conduct monthly meeting of all child protection mechanism in every month in of DCPO. the leadership



Training for CHILDLINE staff has been another point for discussion and as a result of the same a state level TOT has conducted.

Networking visit of the city in charge

Mr. Manoj Joseph, Senior Program Coordinator, CIF conducted two networking visits during the reporting period. Review of the activities done by the team was done during the visit. Meetings with the Directors, Coordinators & Team members were conducted during the visit.

Trainings

A number of 132 Trainings has been conducted by CHILDLINE Trivandrum in the year 2015-16 for the stake holders, staff and children. Police officials, Social work students, Teachers, Anganwady workers and helpers etc., were the participants along with the students from NSS, SPC, NCC etc., Fr. Joye James lead 17 session for the Higher secondary teachers on JJ and POCSO act in collaboration with SIEMAT.

STATE INITIATIVE FOR CHILD PROTECTION

The State Initiative for child protection is a joint venture of Social Justice Department Govt. of Kerala and CHILDLINE Kerala. The main aim of the campaign was to create awareness in the society about child rights, laws and



issues related to children, various redressal mechanisms available, etc. Through this campaign various stakeholders related to children like Teachers, ICDS workers, Social Workers, etc were trained in Trivandrum District. 10 SICP Programs were conducted in Thiruvananthapuram District.

Staff Training: CHILDLINE staff was given training according to the needs. JJ Act 2015, Counseling, Communication for awareness, CSA case follow ups etc., were the topics for staff training. Experts from the field lead the session in participatory method.

Childline conducted one Resource organization meet at Loyola extensions services in 2015-16. Different stakeholders like, Bhoomika, Children's home and other child related Ngo has participated in the Meeting.



Day Observances

Major days were observed with different programs. The day observances has been done with the collaboration of all CHILDLINE Organizations and stakeholders.

CSD: One week long CSD programs have been conducted in collaboration with the schools and the Departments. The Komal Video Presentation during the month of November at Shanghumukam was received good attention from the mass. Awareness classes were conducted during the CSD week at different schools on Child Protection. During the CSD week Child Rights Express an innovative program of CHILDLINE Trivandrum was inaugurated on the first day of CSD. A creative program was arranged during the CSD week at a specially challenged children home.

Global Hand Washing Day:The global hand washing day observance was done in collaboration with schools and Kerala Child Rights Observatory. Hand wshing techniques and awareness campaign was conducted on October 15 in 31 schools.
