What is CHILDLINE?

CHILDLINE is a 24-hour emergency outreach service for children in need of care and protection in India. Any child/ concerned adult can dial 1098 to access this service. This model of service was initiated as a field action project of the Department of Family and Child Welfare, Tata Institute of Social Sciences Mumbai, in June 1996. This was in response to a situation marked by the lack of an emergency service for children, restricted outreach of existing organisations and the adhoc role of allied systems in child protection.

CHILDLINE India Foundation (CIF) was founded in 1999. CIF is the nodal organisation for CHILDLINE service across the country. The goal of CIF is to reach out to marginalised children in need of care and protection.

As of December 2010, CHILDLINE was operational in 88 cities of India spread across 25 states; CHILDLINE 1098 receives over 2 million calls each year. CHILDLINE 1098 is one of the world's single largest children's helpline service and receives 20% of all children's calls on helplines working worldwide. As of December end, 2009, CHILDLINE has responded to over 21

million calls, and has the long term goal of reaching out to every child in distress in each city/district of India.

The XIth 5-year Plan of the Government of India has mandated that the CHILDLINE service must be available in each one

of India's 678 districts. To meet that mandate, the Ministry of Women and Child Development supports CIF under its Integrated Child Protection Scheme.

Target audience

CHILDLINE works with marginalized children from various cities/districts. This includes working with

- Street children and youth living alone on the street
- Emotionally disturbed children
- Child labourers especially in the unorganized sector
- Children who have been abused
- Child victims of the flesh trade

- Differently abled children
- Child addicts, children in conflict with the law
- Children in institutions
- Mentally ill children
- Children affected by HIV/AIDS
- Children affected by conflicts or disasters
- Child political refugees and
- Children whose families are in crisis

Structure of CHILDLINE at the city level

Every city, where the CHILDLINE service is running, has a similar structure, as well as a uniform process in which it assesses the needs of the children, develops a resource directory of organizations in the city, ensures the phones are ringing and provides training to the new team. CHILDLINE functions through a network of NGOs, academic institutions, the corporate sector and the allied systems. The key stakeholders in the CHILDLINE model at each city/district are:

CHILDLINE Advisory Board (CAB) comprises of senior level functionaries from the allied systems, NGOs, concerned individuals, media etc. The CAB reviews information received by local CHILDLINE's from children collated at Open House sessions. The CAB ensures that all Allied systems stake- holder organisations are actively involved in Child Protection in their respective cities.

The Nodal Organisation is mostly, though not always, an academic institution which ensures coordination, training, research, documentation, awareness and advocacy.

The Collaborative Organisation, is the 24-hour service for children, which responds to the calls on 1098, provides emergency intervention if required, links the children to the services for ultimate rehabilitation, conducts awareness and outreach programs and documents every call that comes into CHILDLINE and the intervention or follow up done.

The Support Organisation, responds to calls referred by the collaborative organisation, conducts awareness and outreach programmes.

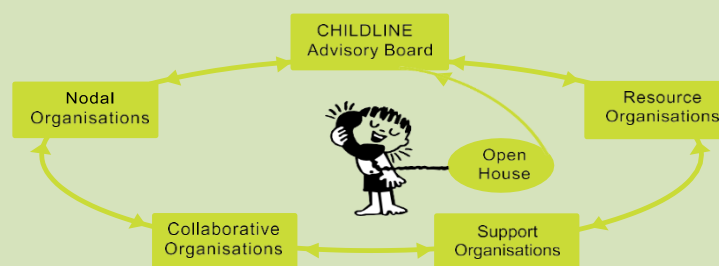
The Resource Organisations act as referral centers for CHILDLINE. They also participate in outreach and awareness programmes for CHILDLINE.

In the district model, Support partners are replaced by Sub Centre partners, which is a mix of Collab and support partners in terms of their roles.

The CHILDLINE Contact Centre (CCC) is the centralized call center initiative of CIF. Currently there is one CCC located in Mumbai; it receives calls to 1098 from several cities in West & North Zones. Intervention calls are forwarded to partners.

CHILDLINE has thus evolved into a partnership between children, the Government, NGOs, academic organizations and the community, at the city and national levels, to respond to the concerns of marginalized groups of children.

CHILDLINE's comprehensive strategy to bring about systemic change by creating child friendly systems has yielded astonishing results. CHILDLINE works with the system and its processes on behalf of the child to reach the goal of a safe child friendly environment. Hence, impact and change are processes that take a considerable amount of time and call for perseverance. It is the surest way to ensure a long-term solution



Intervention methodology

A call coming into a CHILDLINE centre, is attended to, by one of the team members who work in shifts. This ensures the calls are attended to 24 hours a day. Depending on the nature of the call, be it by a child or an adult, the team member will respond to it, either by going to meet the child first and then linking him or her To medical help, shelter, restoration, Protection from abuse or providing intensive counseling as required.

If the team member feels that he will not be able to reach the child soon, assistance from a support organization that is located in the vicinity of the caller is sought. After the emergency is addressed the next step is to link the child with long-term rehabilitation. This involves referral and networking with other organizations providing

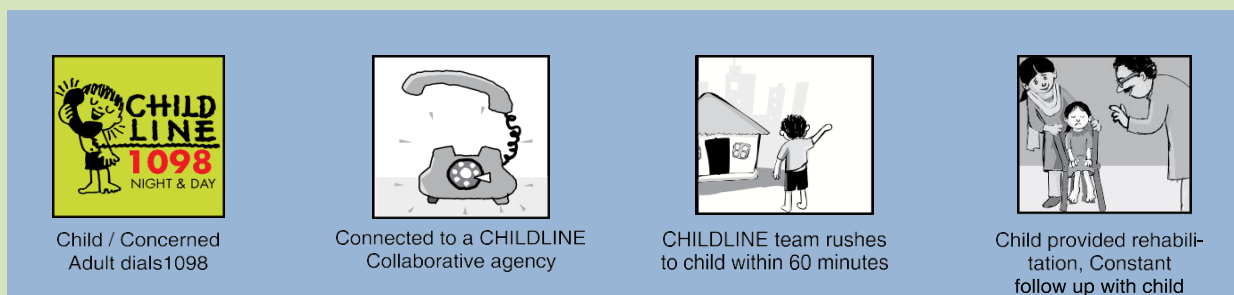
specialized services. The children's participation is an integral component in this process from response to rehabilitation.

CHILDLINE India plays the role of a link between service providers (government, non-government) and children in need of care and protection. All CHILDLINE interventions aim to bring children out of emergency situations, provide options for long term rehabilitation and then link them to appropriate agencies to ensure the same. The period of CHILDLINE intervention may vary from a few hours to a few days and in the case of some children may stretch to years.

CHILDLINE shares a vibrant and dynamic relationship with the children it works with. Ingrained in its daily functioning, is grass root outreach and interaction with children. Monthly Open House, an open forum for children to share feedback about the functioning of the service, as well as share their issues and concerns for themselves, is critical to the functioning of CHILDLINE. City mapping, an extensive exercise to highlight high risk areas where children are prone to abuse, and child protection resources, enables CHILDLINE to priorities and reach out more effectively. Children and youth identify with CHILDLINE and often offer their services as volunteers. They play a critical role in creating awareness about the CHILDLINE service and work as informers who inform CHILDLINE about children in need of assistance. Many of these children and youth grow into the CHILDLINE system and find themselves a space in CHILDLINE centers as paid volunteers or team members.

CHILDLINE works at three levels, functioning as a catalyst to effect systemic change. At the micro level it responds to children on the 1098 helpline, providing them emergency assistance and then linking them to agencies/family for long term rehabilitation. At the mezzo level, CHILDLINE works with the local system comprising state governments, municipal corporations, district administrative units, village panchayaths, community group's voluntary agencies and academic institutions to create child friendly systems.

At the macro level, CHILDLINE works as a catalyst bringing the government, the corporate sector and voluntary agencies together to bridge gaps in the services, address policy gaps, increase budgetary allocations and explore the adaptation of technology for child protection mechanisms in India. It envisages a cohesive child protection force comprising the state, the corporate sector, voluntary agencies and the community working together to ensure each child his/her right to protection.

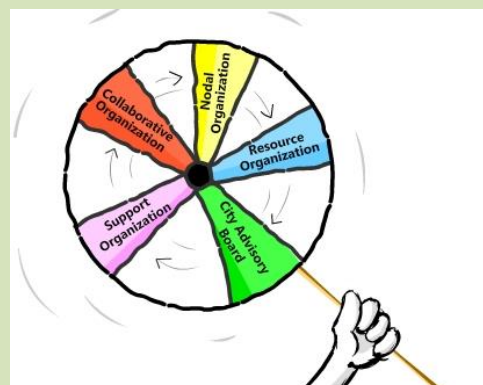

Long-term rehabilitation

After the emergency needs of the child have been addressed, CHILDLINE explores options with the child to study, learn a trade, go back home etc. Based on the decision of the child, CHILDLINE links the child to an appropriate organization in the city.

Structure of CHILDLINE at the local level in any city/district

CHILDLINE functions through a network of NGOs, academic institutes, the corporate sector and the allied systems. The focus of the service is to reach out to every marginalized child and hence programs must be designed accordingly.



CHILDLINE Advisory Board (CAB) comprises of senior level functionaries from the allied systems, NGOs, concerned individuals, media etc. It is the policy making body for CHILDLINE at the city level and it periodically undertakes reviews of CHILDLINE.



The Nodal Organization, essentially an academic institute ensures coordination, training, research, documentation, awareness and advocacy.

The Collaborative Organization, essentially a 24-hour service for children, responds to calls on 1098, provides emergency intervention, links children to services for ultimate rehabilitation, conducts awareness and outreach programs, and documents every call that comes into CHILDLINE.

The Support Organization responds to calls referred by the collaborative organization, conducts awareness and outreach programs.

Resource Organizations: These organizations act as referral centers for CHILDLINE. They also participate in outreach and awareness programs for CHILDLINE.

CHILDLINE operates in 521 cities by 'partner organizations' - a range of large, medium, and small child rights agencies. Locally, they run the full CHILDLINE service weaving 1098 into their organizational canvases. Nationally, they make up the spine of CHILDLINE.

CHILDLINE Thiruvananthapuram

Being a torchbearer for the entire program CHILDLINE Thiruvananthapuram is the first wing of its kind in the whole state which was started in the year 2000. Loyola Extension Services (LES) Trivandrum works as the Nodal Organization. LES along with the Collaborative agencies, Don Bosco Veedu Society and, Trivandrum Social Service Society and Railway child Help Desk (Don Bosco Veedu society) has done many activities in the city for children. Providing services to the children in need of care and protection, coordinating with Government Departments, networking with the members of the allied system, organizing various programs, etc. were done to prorogate the activities of CHILDLINE. CHILDLINE India Foundation is the core support for the smooth functioning of the various activities. This report is the glimpse of the activities of CHILDLINE Thiruvananthapuram during the period of 1st April 2018 to 31st March 2019.

Child Labor intervention Analysis 2018-2019

Channel of Reporting

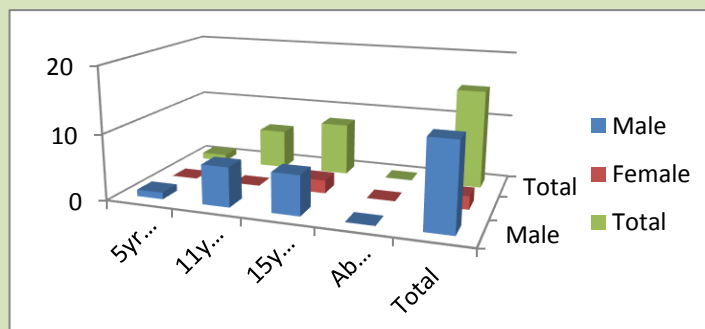
In the year 2018-19 CHILDLINE Trivandrum intervened in 15 child labor cases. In which 9 cases were informed through centralized call center and 6 intervention known by outreaches.

Intervention Analysis

The children who are rescued ranged from 5 years to 18 years, 1 child was among the 1-10 age category, 6 children were 11-14 years of category . 8 children were above 14 years of age. Out of fifteen cases 4 children were only from kerala and rest are from other states. It is an indicator that, there are only few cases reported in Kerala and all most all the children are in school and the dropout rate are also less. Children from all religious background tend to come for child labor is also a conclusion that the religious sentiments are not working when connect to child labour but the poor family background and relation is.

Circumstances of child /Adolescent employee.

It is to be analyzed that why the children though they want to be happy came to work in difficult circumstances and how they were treated. Four children were in to child labour because they were mentally harassed by others and parents. Two children were rescued because they worked more hours than the hours set by law. 6 children were sharing their accommodation with



adult employees. Two children is rescued when seen working in the night hours. For child salary was cash in hand and for one adolescent child the payment is said to be paid others.

CHILDLINE Follow-up Services Provided

When a child is rescued by childline the child will be given all kind of support, food shelter, transportation facilities counseling what ever they need. Out of fifteen children 7 were given nutrition , 6 were given accommodation facilities and 6 were given clothing facilities. 13 children were re united with their parents and two were transferred to other states/children's homes. Out of 15 cases 6 cases were informed to District labour office and 9 were produced before CWC. 4 cases are reported to DCPU . in three cases police involved in rescuing children. Presentsly 11 children are with parents and 4 children are with relatives, which means that the intervention by childline made the children's life colorful.

Support provided by CHILDLINE in Child Labour Intervention

In all cases childline gave emotional support and guidance to children. In 11 cases parents sensitization were given. Childline also escorted with 8 children to CWC and escorted with 6 children to shelter home. Also in two cases arranged collaboration with DCPU. In 4 cases childline team members given service as witness to the cases.

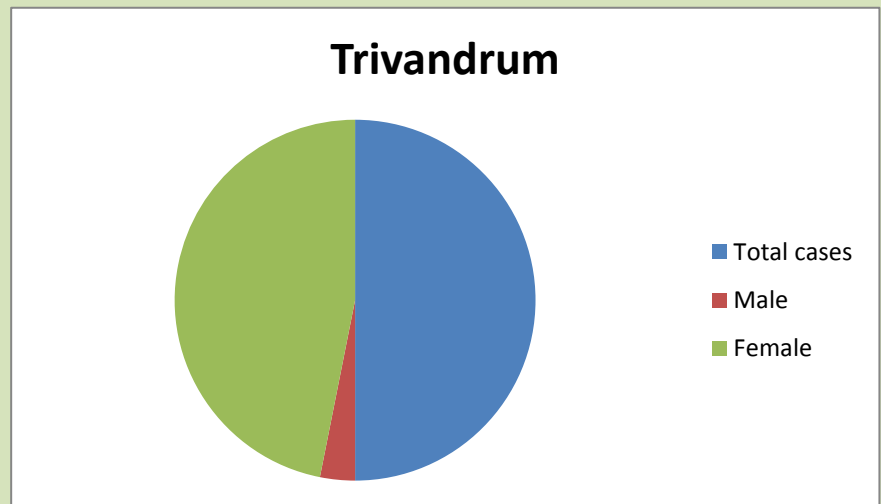
Child Marriage Analysis 2018-2019

In Thiruvananthapuram child marriages interventions are less in number when compared to the other parts Kerala. But the status of child marriages in percentage of the growth rate is increasing in southern districts like Kollam and Trivandrum, Though a small decrease is shown compared to last year. The cases intervened childline Trivandrum makes this point clear.

In 2018-19 childline 16 child marriage interventions were reported in which 15 were of female children and one male child was there. All the cases reported are above 13 years of age and 13 cases were in between 16-18 years of age. The facts clearly shows the chance of getting eloped or marriages among teenagers. It also shows that it is not a custom among any community to getting their children to marry before 18 years of age. The Children from poor income category and SC ST communities also had child marriage cases. Childline in collaboration with other departments stopped 10 child marriages and five marriages were informed after the marriage only. One case could not stop since the child and family changed their place of Residence.

The continuous support by the CDPO s in Trivandrum to be noted and also the other departments in helping children through networking with CHILLINE. The injunction orders are taken in all cases that is reported to them. Five FIRs were filed during this year against the child marriage.

7 people were arrested during the process 4 boys and two boys parents and one girls parents were arrested. The information of child marriages are received from all stake holders also is a pointer of awareness created by childline during the past years of work in trivandrm. Teachers (1), Anganwady Workers (2) Friends (20) Relatives (3) and Niegbours (4) joined the group along with police and other authorities as informant.



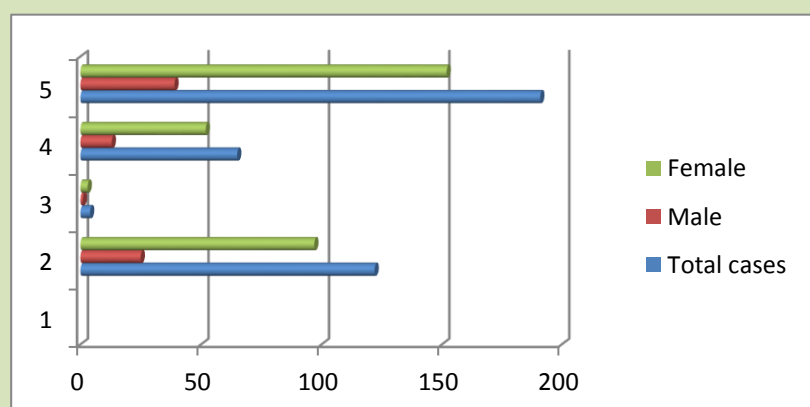
In all the cases police involved in helping the children, CDPOs involved in 13 cases aDCpu staff also involved in 9 cases etc., shows te linkage and networking childline has in the city.

Another alarming factor is that all the cases are not love marriages almost 52 % of marriages are arranged marriages and 48 % of marriages are love marriages without the knowledge of their parents. There were six cases in which the child has no prior relation with the groom. Here also 7 cases were informed as love relation. 90% of cases are reported through childline also shows the reach of CHILDLINE awareness among the citizens of the district.

CHILDLINE could saves lives of many children through intervening in child marriage cases. 95 % of child victims were given emotional support and guidance directly by childline. In 13 cases parent sensitization was given and in 4 cases childline staff escorted th children to avail shelter in children's homes. Analyzing the present status of children, 10 Children are with the parents nd 4 are in the children's home and one child is with the relatives. 9 Children back to the normal life soon after the intervention and other children are also in the process.

Intervention of Child Sexual Abuse Analysis 2018-2019

Child Sexual abuse is alarmingly increasing everywhere in India. Most cases are reported in kerala because of state's leagal literacy and social commitments. Childline Trivandrum has a wide range of awareness programs



through media and outreach and awareness program and trainings, which result in reporting of cases in childline-1098. The analysis of Child Sexual abuse cases will also reveal the fact. Both male and female children are being sexually abused everywhere. 39 male children and 152 female children were sexually abused in Trivandrum during the year.

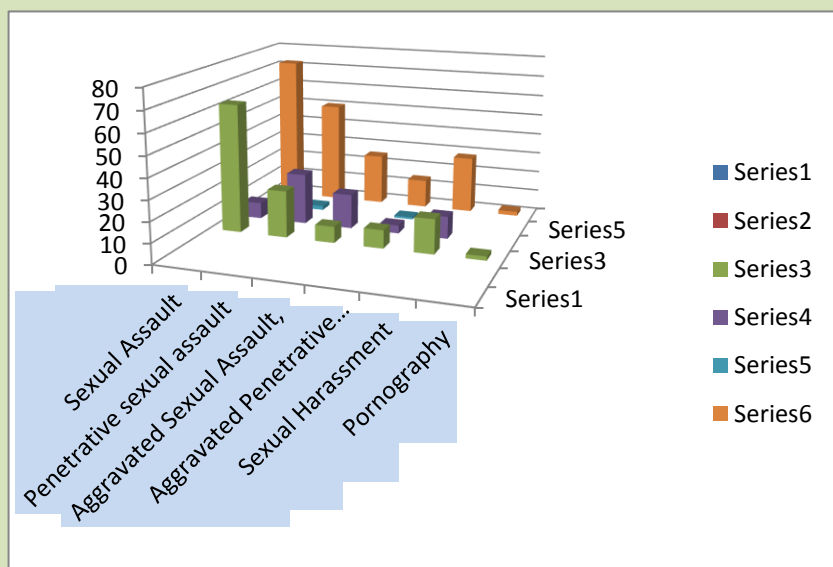
The age group of children abused is more in 11-15 years of age. A number of 81 children are in this category. The nature of abuse also is revealing the fact that the children are facing severe form of Sexual abuse. Out of 191 cases 161 cases were sexual assault cases.

As every one knows now a day children are being abused by known people. The analysis this year also shows the same. The known people included friend or lover, relatives, neighbours and others. It is here the need of parenting education and child rights education to be reached to the families now. Only 29 cases are reported as others or strangers are abusers.

Home is the most safe place for everyone but not for the sexually abused children. 80 children revealed that they were abused at their own houses, 60 children were abused at abusers house shows that they are not safe at their homes. Also in seven cases child victimized by multiple offenders.

Since the CHILDLINE reaches everybody through the awareness and training using different methods the stakeholders ranging from teachers to doctors report the cases to childline either through 1098 or during outreach programs. 124 CSA cases were reported through CHILDLINE 1098 number.

The analysis shows that the children are being abused at their houses and by the known people. If the reporting is late and the child is being used by the known people the chance for repeated offence is higher. The linkage can be seen here that 30 cases were



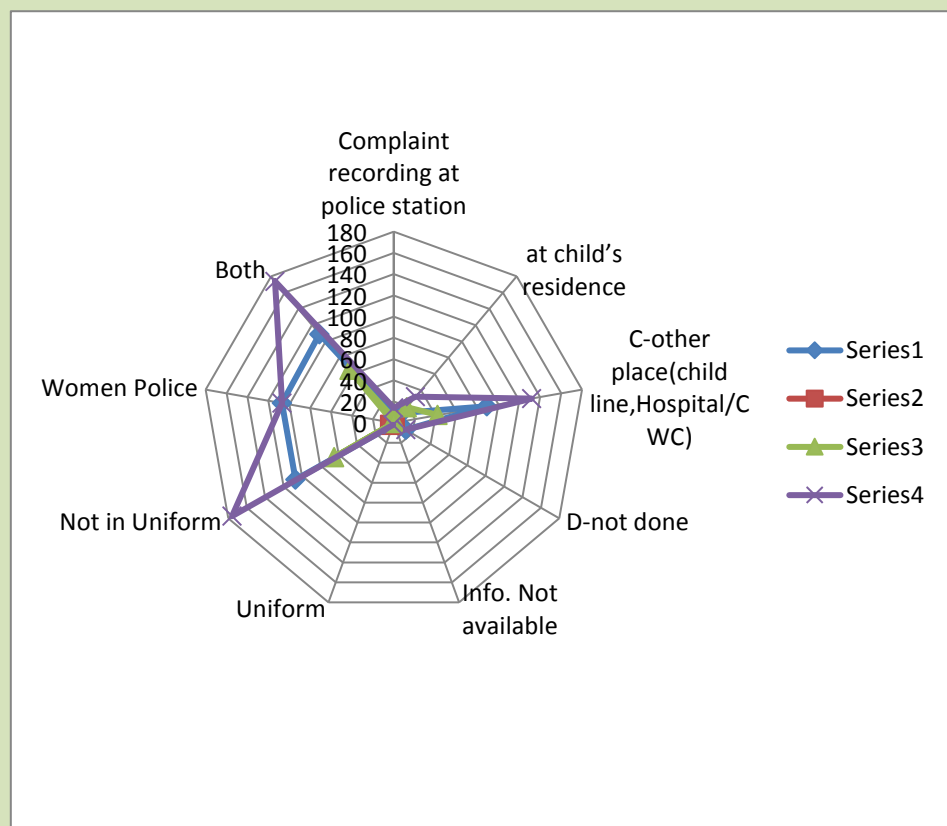
reported after one year, 98 cases between 1-6 months' time gaps. The same can be correlated with the analysis and can be seen that 122 cases children revealed that they were abused more than one time and 14 children suffered abuses more than 5 times.

Analyzing the trend of reporting to the CHILDLINE found that 119 cases were reported before going to police stations revealing the trust that public has on childline services.

It is also to be noted that blood relatives are also abusing children, whom we suppose that the children will be taken care of. 34 cases are reported in which father or step father or grandfather abused children. The children are being abused seriously by their incest. In 68 cases incests abused the children also was sexual assaults or penetrative sexual assaults.

Considering previous years report there were no online abuse reports was there. In this fiscal year child line received 7 cases were reported which gives an alarming factor that online abuses to be addressed now in the district. It included showing pornographic pictures and sending messages to children. Responsible Social media use also to be given awareness to tackle the issues.

In almost all cases the FIR were registered against the abuser, Abusers arrested in 168 cases, Six Children who were involved in CSA were also produced before Juvenile justice Board for correction and rehabilitation. Awareness among the public is being done by the organization involved in childline made the public to report the



cases to the childline. Almost 90% of the cases parents are willing to file complaint, which is a felt need to bring the abuser before law in many cases.

The need of the services of CHILDLINE in a city is assessed through the service provided by CHILDLINE in protection from abuses cases. In all Child Sexual abuse cases in Trivandrum CHILDLINE gave emotional support and guidance to child. In 185 cases parents sensitization was given. CHILDLINE staff escorted to CWC for shelter to the child and in 12 cases escorted for medical examination. In 110 cases escorted to bhoomika or shelter homes. Since the child's education is lost after such abuses childline also given services to 31 children to support for school enrolment or restore education. Allied systems were also included after the linkage by childline to other departments. In 51 cases to DCPU, 28 cases

linked with DLSA, 12 cases to CWC or other jagratha samities etc., Victim compensation scheme also arranged after linking with DLSA and DCPU.

According to united Nations Convention on the rights of children and JJ Act child friendly procedure is a must for the brning back children to normal life. When Child sexual abuse cases is analysed in Trivandrum it is found that now the system is in place and all the stakeholders are following the child friendly procedure to a great extend. It is analysed through the number of intervention in which child is comfortable in taking informations, approaches of police and authorities, etc., in five cases it is said that victim brought in contact with the accused also to be abolished in order to protect children.

Analysing the present status of survivors it is came to know that 90% of the survivors are back to their noram rutine after intervention by childline. 4 children are under vocational training. Due to different reasons some are under trauma for a long time in wchich childline is following up the interventions. Most of the children are with their parents itself is a hint of positive intervention by childline 135 children are with their parents, 17 are with their guardians and only 39 children are in shelter home.

It is to be noticed that 17 teenage pregnancies reported during the year 2018-19 out of 191 cases, which is an alarming factor of heinous offences against children. 7 children gave birth to children and 8 went for abortion one child was abandoned

Physical Abuse

Analysis of physical abuse case against children is need of this era, because the large number of abuse cases come under physical abuse category. There were 311 physical abuse cases were reported in Childline Trivandrum during the year 2018-19 out of which 133 female and 178 male children were physically abused.

All most all ages of children are physically abused equally, and both male and female children are also abused. 50 children were below the age of 5, 75 children aged between 6-10, 113 children aged between 11-15 and 59

children were 15-18 years of age. Here also we can see that the children between the age of 11-15 are those who are abused physically more than comparing to other age groups.



Another alarming factor is that 69.45 % of abusers are within the family . it consists of father (138) cases mother (26) cases Step father 16 cases etc.,

Abuses are also there who are nor part of the family. There were 26 cases in which neighbours physically abused the children, two shopa keepers, 5 bus workers, 44 school teachers or PTAs, 8 Madrasa teachers , 3 friends two police men and 4 strangers also joined this list when analyzing.

Analysing the nature of abuse 173 cases were beating with hand, 46 cases reported beating with cane and stick, 4 cases reported in beating with iron rod, and 24 cases reported attacking with any other object and 14 children denied food casuing strave, two burning injuries were also reported and 48 other forms of physical abuses. It clearly shows that the physical abuse against children are still there in our society. Most of them may not be pre determined.

In most cases injuries were seen clearly in abuse in seven cases injuries were on head, 6 born fracture cases reported and 90 wounds. There wer 12 cases in which scar on the body and 9 cases swelling on the faces 17 cases swelling on chidlren's hands 5 caes welling on legs and 146 cases were other injuries.

IN all the caess childline could give care and protection to children by giving complaints to police, reporting to CWC, teaken to hospitals, visiting schools etc.,

Another factor is that the compromising of cases, only in 52 cases abusers were arrested, 163 cases abusers were not arrested, because we can see that in 236 cases were compromised we also found that most of the physical abuse cases had connectin with adult issues.

Awareness and Outreach

Awareness and Outreach: Using methods like Word of Mouth Communication, distributing palmlets, etc. Thampanoor IU conducted 762 major awareness programs during the year for teachers, health workers, parents, youth, drivers etc., . They also conducted 1589 outreach programs during the year. **Railway CHD conducted 364 railway outreaches and 1615 grass root level outreaches. To be completed**

Advocacy Efforts

Team & Coordinators Meet

12 coordinators & 13 team meetings were held during the reporting period. 58 meetings were conducted in Thampanoor IU. The Vellayambalam IU conducted forty meetings. Railway CHD conducted 39 weekly meetings. The city coordinator visits both collab and support

frequently to assess the work and to give proper guidance as and when needed. Various activities and strategies were planned during the meetings to implement the activities effectively. Staff development programs were also initiated during the period.

Directors' Meeting

Two Directors meeting were held during the reporting period. And in the meeting major decisions on awareness creation for stake holders and awareness on preventing child sexual abuse was to be done. Area division was done since the new area was given to vellayambal IU because of the up gradation from support agency to collab agency.



District Collector's Meeting and DCPC Meeting

In the leadership of DCPO of Trivandrum there is regular meeting with collector to evaluate the child protection mechanisms in which childline presents the monthly case intervention and other programs. There are three District Child Protection Committee Meeting were conducted during the period. Two DCPC meeting were conducted during the fiscal year in which the meeting decided to give more importance to creating safenet to children so as to strengthen the VCPCS of the district with the joint venture of CHILDLINE, dcpcu and the district panchayath.

Resource Organization Meeting

CHILDLINE as it work with the networking with like minded NGOs, Departments and people with out the organization related to child related work cannot function well. In order to strengthen the work CHILDLINE conducts resource organization meeting for its stakeholder organisation on 26-7-18 and 26-03-17 at Loyola extension services. During the meeting discussion on JJ act and Principles also



ect was done.

Networking visit of the CIF Representatives

Mr. Manoj Joseph, Senior Program Coordinator, CIF conducted one network visit during the reporting period. Review of the activities done by the team was done during the visit. Meetings with the Directors, Coordinators & Team members were conducted during the visit. State level networking visit also conducted to different departments of State Government during the Visit.



Trainings

A number of 119 Trainings has been conducted by CHILDLINE Trivandrum in the year 2016-17 for the stake holders, staff and children. The training for Police officials at (KEPA was marked best of it kind in collaboration with the UNICEF), Social work students, Teachers, Anganwady workers and helpers etc., were also conducted along with the same for students from NSS, SPC, NCC etc., Fr. Joye James SJ, Director CHILDLINE Nodal, lead 9 sessions for the Higher secondary teachers on JJ and POCSO act in collaboration with SIEMAT.

Special Program conducted by Railway CHD

1. The Child Protection group was constituted on 6-7-18 in the leadership of Dr. rajesh Chandran IRTS, Director of Indian Railways,
2. Training for RPF officials was conducted on 28-9-18 in which 42 participants were given training on SOP and Laws related to children.
3. Training for GRP officlas was conducted on 12-10-18 in which 30 participatns were given training on SOP and Laws related to children
4. On 17 10 18 railway stake holders meeting was conducted in CIF Head and railway stake holders participated.
5. The first anniversary celebration of Railway CHD was done on 1-2-19
6. Training for Second batch of RPF officials was conducted on 4-2-19
7. Training for second batch of GRP officlas was conducted on 15-2-19

Capacity building for CHILDLINE Staff

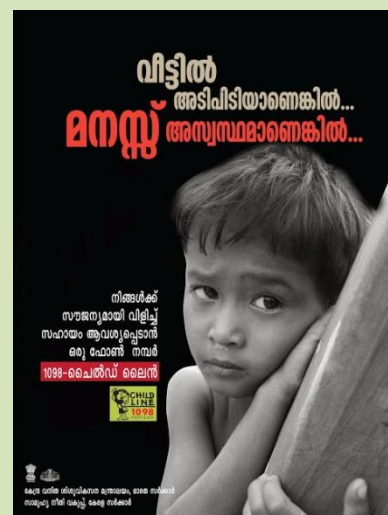

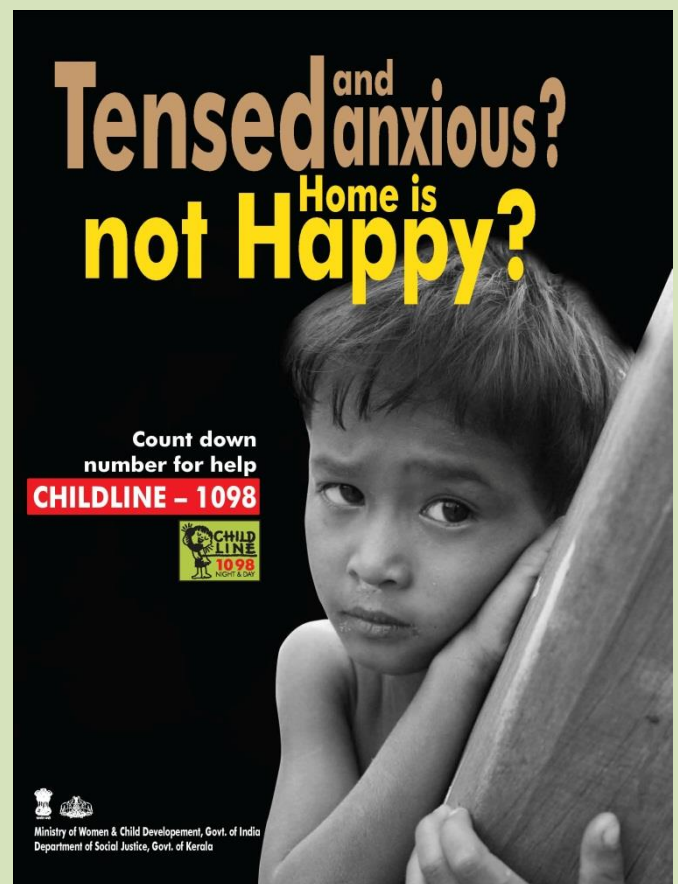
